The IR-4 Project is a publicly funded effort to support the registration of pest control products on minor use crops. In 2001, IR-4 continued to be active in weed science, conducting and submitting many herbicide projects for weed control.

| Oxyfluorfen: | strawberry (annual and perennial) |

| Pendimethalin: | tree nuts (includes almond and pecan), pistachios, almond hulls, and fruiting vegetables (includes eggplant, pepper (bell and non-bell), and tomato) |
| Triflurosulfuron: | chicory root |

| Clomazone: | tuberous and corm vegetables (except potato) subgroup (includes cassava, sweet potato, tanager, yam and apio nabo) and the melon subgroup (includes cantaloupe and watermelon) |
| Clethodim: | cranberry, clover (seed), fruiting vegetable group (includes eggplant, pepper (bell and non-bell), and tomato), leaf petiole subgroup (includes celery and rhubarb), cucurbit group (includes cantaloupe, watermelon, cucumber, pumpkin, summer squash and winter squash), onion, root vegetable (except sugarbeet) subgroup (includes carrot, horseradish, and radish), strawberry, and tuberous and corm subgroup (includes garden beet, carrot, horseradish, radish, and turnip (roots and greens)) |
| Paraquat: | dry pea (Pacific Northwest only) |
